**4. Lakers Property Site**

Riley Dueck, RM Certified Engineer Technologist, presented the proposed Lakers Site map. Key points included:

- A. Discussion on relocating the snowmobile trail either north of the boat house or slightly south near the treeline.
- B. Agreement to reposition the parking lot along the driveway with construction scheduled for Spring 2025.
- C. the skating trail will be established north of the Lakers Site, away from the ice fishing shacks and snowmobile traffic.
- D. A Long-term temporary setup for visitation shelters was agreed upon by both councils, pending the signing of Recreation Facility agreement.

**5. Lakers Joint Recreation Agreement**

The Joint Recreation Agreement was tabled to the next joint meeting, allowing further collaboration on proposed amendments between administrations.
